1. IDENTIFICATION OF SUBSTANCE/PREPARATION & COMPANY.

2. COMPOSITION / INFORMATION ON INGREDIENTS.

DEFINITION/BOTANICAL ORIGIN: The oil obtained by infusing the leaf of the comfrey - plant *Symphytum officinale*, in Sunflower Oil - *Helianthus annuus* in the ratio of herb:oil 1:10

3. HAZARDS IDENTIFICATION:

4. FIRST-AID MEASURES:

INHALATION: Remove from exposure site to fresh air. Keep at rest. Obtain medical attention.

EYE CONTACT: Rinse immediately with plenty of water for at least 15 mins. Contact a doctor if symptoms persist.

SKIN CONTACT: Remove contaminated clothes. Wash thoroughly with soap & water, flush with plenty of water. If irritation persists, seek medical advice.

5. FIRE FIGHTING MEASURES.

EXTINGUISHING MEDIA RECOMMENDED: Use CO₂, Dry Powder or Foam type Extinguishers, spraying extinguishing media to base of flames. Do not use direct water jet on burning material.

7. HANDLING & STORAGE.
