**Note: LIME OIL COLD PRESSED ORGANIC contains furocoumarins** (see separate documentation for details)

LIME OIL COLD PRESSED ORGANIC is restricted (48<sup>th</sup> amendment to the IFRA Standards) under the terms of the Standard 'Citrus oils and other furocoumarin containing essential oils.' This Standard limits the bergapten (5-methoxypsoralen) content in finished products intended to be placed in contact with skin exposed to sunshine and not washed off to 0.0015%w/w (15ppm). This does not include products intended to be rinsed off the skin and household cleaning products or products for which there is minimal or no intended skin contact.

LIME OIL COLD PRESSED ORGANIC is also restricted (48<sup>th</sup> amendment to the IFRA Standards) to a maximum concentration of 0.7% w/w in finished products intended to be placed in contact with skin exposed to sunshine and not washed off. This does not include products intended to be rinsed off the skin and household cleaning products or products for which there is minimal or no intended skin contact.

#### When used in combination with other fragrance materials:

LIME OIL COLD PRESSED ORGANIC contains Linalool and limonene that are subject to an IFRA specification and citral and geraniol that are subject to a restriction in the total amount present in a finished product. Citral is present at a maximum level of 7.0%w/w and geraniol at a maximum level of 0.4%w/w. (see below for details)

### Note: essential oils containing Furocoumarins

If LIME OIL COLD PRESSED ORGANIC is used in combination with other furocoumarin containing fragrance ingredients its level of use must be reduced accordingly. The sum of the concentrations of all phototoxic ingredients, expressed as a percentage of their recommended maximum level in the consumer product shall not exceed 100.

Where the bergapten (5-methoxypsoralen) content of all relevant oils present in a product has been determined, it is recommended that for application on areas of skin exposed to sunshine, excluding bath preparations, soaps and other products which are washed off the skin, the total level of bergapten in the consumer products should not exceed 0.0015% (15 ppm)

Where the furocoumarin levels of all the furocoumarin containing ingredients have not been determined LIME OIL COLD PRESSED ORGANIC should be restricted to a maximum level of 0.7%w/w.

**NOTE:** <u>IFRA standards do not necessarily reflect restrictions for furocoumarins in the cosmetic regulations or SCCS opinions.</u>

#### Cosmetic Regulation EC 1223/2009 as amended

The following allergens listed in in Annex III to the above regulations are present in LIME OIL COLD PRESSED ORGANIC at the maximum concentration as follows:

Limonene 55.0%w/w, Linalool 0.2%w/w, Citral 7.0%w/w, geraniol 0.4%w/w

**For other kinds of application** or use at higher concentration levels, a new evaluation may be needed.

The IFRA Standards regarding use restrictions are based on safety assessments by the Panel of Experts of the RESEARCH INSTITUTE FOR FRAGRANCE MATERIALS (RIFM) and are enforced by the IFRA Scientific Committee.

Evaluation of individual Fragrance ingredients is made according to the safety standards contained in the relevant section of the IFRA Code of Practice.

It is the ultimate responsibility of our customer to ensure the safety of the final product (containing this fragrance) by further testing if need be.
